### Approval of Minutes

Chairman Way stated the first item of business was the approval of the minutes from meetings held on November 15, 2017 (SEC), November 17, 2017 (SBC), December 1, 2017 (SBC) and January 5, 2018 (SBC). Mr. Benson moved to approve the minutes. The motion was seconded by Ms. Bowers. The minutes were approved unanimously.

### New Business

Chairman Way stated that the first item of new business was the Presidential Advisory Commission on Election Integrity. Ms. Andino informed the commissioners that the commission has been disbanded.

The next item of new business was legislative updates. Ms. Andino advised that the General Assembly has returned and there will be a conference committee on bill S107 relating to the joint election of the Governor and Lieutenant Governor. Ms. Andino explained that the conference committee is aware of the SEC's need to modify and test the candidate filing system prior to the opening of candidate filing in about 60 days. Ms. Andino reminded the board that although the constitutional amendment regarding the joint election of the Governor and the Lieutenant Governor was passed, the General Assembly has not passed legislation that would define how the process would work.

Ms. Andino advised that the Governor has released his proposal for the budget and that it included \$250,000 in recurring funds for cyber security, \$650,000 to recoup expenses for the unusually large number of special elections held in FY2017 and FY2018, \$10 million for seed money for a new voting system and \$4 million for a refresh of the existing voting system. Ms. Andino also informed the commissioners that the budget is currently in the House of Representatives and the agency presented the budget request to the House Ways and Means Subcommittee yesterday.

### **Old Business**

The first item under old business was the status of the House Legislative Oversight Committee (HLOC) study. Ms. Andino advised that the Executive Subcommittee presented the study of the SEC to the committee, which adopted the subcommittee's report. She also reminded the board that although the study has concluded, the SEC will update the committee every year. The study will be made public on the HLOC's website.

The next item under old business was an information technology security update. Ms. Andino advised the commissioners that county users will be required to participate in Securing the Human, an information technology security training that is geared for non-IT professionals. She also advised that all elections held this year will be conducted using the new version of the election management system.

Chairman Way reminded the members that the State Board of Canvassers will meet on Friday, January 19, 2018 at 3:00 p.m. The next meeting of the State Election Commission is scheduled for Wednesday, February 21, 2018 at 10:00 a.m.

Chairman Way called the meeting to order and asked if all notices of the meeting had been posted as required by the Freedom of Information Act. Ms. Andino stated that the notices had been posted. Chairman Way informed the commissioners joining the meeting via teleconference that Ms. Joanne Day from the League of Women Voters was present at the meeting.

### Approval of Minutes

Chairman Way stated that the first item of business was the approval of the minutes for meetings held on January 17, 2018 (SEC) and January 19, 2018 (SBC). Mr. Benson moved to approve the minutes. The motion was seconded by Ms. Bowers. The minutes were approved unanimously.

### **New Business**

Chairman Way stated that the first item of new business was the filing of Statement of Economic Interests with the Ethics Commission. Ms. Andino reminded the commissioners that those must be filed by March 30, 2018.

The opening of candidate filing for the 2018 General Election was the next item under new business. Ms. Andino informed the board that candidate filing is just three weeks away, from March 16<sup>th</sup> through the 30<sup>th</sup>. Ms. Andino further advised that the SEC anticipates approximately 1,000 candidates to file across the state. She also stated that it is an opportunity to educate candidates on cybersecurity, and that the Belfer Center at Harvard University has compiled some information on how to protect

campaign information. She further stated that the SEC will use the Belfer Center's information during 2018. She also advised that information and reminders will be communicated to the counties on how to conduct candidate filing.

The next item of new business was the Center for American Progress: Election Security in all 50 States publication. Ms. Andino informed the commissioners that this study focused on seven areas of election security and preparedness: minimum cybersecurity standards for voter registration systems, voter-verified paper ballots, post-election audits that test election results, ballot accounting and reconciliation, return of voted paper absentee ballots, voting machine certification requirements, and pre-election logic and accuracy testing. Ms. Andino reported that South Carolina received a score of D. She further explained that unsatisfactory grades were given due to the voting system being paperless, that post-election audits cannot be tested against a paper record and that ballots from voters living overseas or military members stationed overseas are accepted electronically. Cybersecurity standards for the voter registration system were given a grade of good.

#### **Old Business**

The first item under old business was legislative updates. Ms. Andino informed the commissioners that Senate bill 107 relating to the joint election of the Governor and the Lieutenant Governor is still in conference committee. She further advised that an opinion was requested from the Attorney General's office and that the SEC has been informed that the referendum passed by voters is self-executing and that the SEC has the authority to proceed and fill in the gaps.

The budget update was the next item of old business. Ms. Andino informed the commissioners that the budget request was presented to the Senate Finance Subcommittee. She further informed them that the House Ways and Means committee is deliberating the budget this week and the budget will be discussed on the floor of the House next week. The request includes \$250,000 in recurring funds for cybersecurity, \$650,000 to recoup the expenses of the unusually high number of special elections held last year, \$20,000,000 for a new voting system and \$4,000,000 for a refresh/refurbish of the current voting system.

The next item under old business was the PEW grant. Ms. Andino advised the board that the SEC has received a grant in the amount of \$177,000 which would allow the SEC to have access to the Electronic Registration Information Center (ERIC) where the SEC would be provided a list of voters who have moved on a regular basis. She also advised the board that in order to receive the funds from the grant, South Carolina must be a member in good standing by March 31<sup>st</sup>. She further advised that 23 states currently are members.

The next item under old business was an information technology security update. Ms. Andino informed the commission that all county election staff who have access to VREMS, ElectionNet, and the voting system are required to complete cyber awareness training. She stated that out of 46 county directors, 43 have already completed the training. She also informed the board that out of 221 users, 204 have completed the course so far to date. Ms. Andino also advised that the U. S. Department of Homeland Security continues to perform scans on the SEC's infrastructure and no vulnerabilities have been detected. She further advised that the SEC continues to meet with the Department of Administration's Department of Technology who also perform monthly scans. She also informed the commissioners that she recently attended a security briefing in Washington, DC, held by the National Counterintelligence & Security Center for state election directors.

Chairman Way reminded the members that the State Board of Canvassers will meet on Friday, March 2, 2018 at 10:00 a.m. The next meeting of the State Election Commission is scheduled for Wednesday, March 21, 2018 at 10:00 a.m.

With no further business to be discussed, Mr. Benson moved to adjourn the meeting. Ms. Bowers seconded the motion. The motion passed unanimously, and the meeting adjourned.

### **New Business**

in the case. Ms. Andino advised the board that updates will be provided to them as the case moves forward.

### **Old Business**

The first item under old business was a reminder for all board members to file their Statement of Economic Interests forms which are due to the Ethics Commission by March 30, 2018.

The next item under old business was candidate filing, which opened on Friday, March 16, 2018 at noon and will close at noon on March 30, 2018. Ms. Andino advised that as of March 20, 2018, a total of 464 candidates have filed statewide, 45 of which filed at the State Election Commission (SEC) office.

Legislative updates were the next item under old business. Ms. Andino informed the board that House bill 4977 regarding the joint election of the Governor and the Lieutenant Governor passed on Wednesday, March 14. It was ratified and signed by the Governor on Thursday, March 15.

The budget was the next item of old business. Ms. Andino advised that the budget has passed in the House. She informed the board that it includes \$250,000 in recurring funds for security, \$650,000 to recoup expenses of the many Special Elections held last year, \$4,000,000 in recurring funds for the voting system replacement and \$4,000,000 for a voting system refresh of the current system. She also advised that the budget is currently in the Senate Finance Committee.

The next item of old business was the PEW grant. Ms. Andino reminded the board that the SEC received a grant in the amount of \$177,000 from the Pew Charitable Trust which would make the SEC a member of the Electronic Registration Information Center (ERIC). Ms. Andino explained that membership would require the South Carolina Department of Motor Vehicles (DMV)'s participation, and the SEC will not be able to join without providing the DMV data. Ms. Andino advised that there have been discussions with the DMV regarding this matter and the DMV will need to advise the SEC by March 31st if they will be able to provide the data. Chairman Way inquired as to who operates ERIC. Ms. Andino stated that ERIC is operated by the 23 currently participating states. She also advised that in order to keep the grant, the SEC must be a member in good standing by March 31st.

The information technology security update was the next item of old business. Ms. Andino reminded the board that the Department of Homeland Security has designated elections as a critical infrastructure subsector. She explained that all critical infrastructures are governed by Government Coordinating Councils. She informed the board that she has been appointed to the Government Coordinating Council for the election sector. She also advised that the Multi State Information Sharing & Analysis Center (MS-ISAC) was formed a few weeks ago to serve as a multistate information sharing center. She reported that 9 counties have already joined.

Ms. Andino advised that the Department of Homeland Security's weekly scans for the SEC show no new vulnerabilities. She also advised that the Division of Technology (DTO) is in the process of developing an enhanced secure file transfer system between the counties and the SEC. She further informed the board that, once the DTO has finished configuring the device, the security firm, Soteria, will perform a full assessment. Ms. Andino also advised that all county directors and 98% of county staff have completed the online security training "Securing the Human".

Chairman Way reminded the members that the next meeting of the SEC is scheduled for Wednesday, April 18, 2018 at 10:00 a.m.

With no further business to be discussed, Mr. Benson moved to adjourn the meeting. Ms. White seconded the motion. The motion passed unanimously, and the meeting adjourned.

Chairman Way called the meeting to order and asked if all notices of the meeting had been posted as required by the Freedom of Information Act. Mr. Brant stated the notices had been posted. Chairman Way informed the commissioners joining the meeting via teleconference that Ms. Joanne Day from the League of Women Voters was present at the meeting.

### Approval of Minutes

Chairman Way stated the first item of business was the approval of the minutes for the SEC meeting held on March 21, 2018. Mr. Benson moved to approve the minutes. The motion was seconded by Ms. Bowers. The minutes were approved unanimously.

### New Business

The first item of business was the Statewide Primary Preparations. Mr. Brant reported that the candidate filing period closed on March 30<sup>th</sup> and a total of 797 candidates filed statewide. He stated ballot proofing and testing is now being conducted in order to meet the April 28th deadline to mail absentee ballots to military and overseas citizens. Mr. Brant advised a workshop will be held on April 26th to help the counties prepare for the primaries. He informed the board a proclamation is being requested from the Governor to name the month of May as Voter Education Month.



### **Old Business**

The first item of old business was the certification of Unity 4.0.0.3, Version 4, previously submitted by ES&S. Mr. Brant informed the board this certification is on hold until after the primaries and runoffs as there is not sufficient time for parallel testing, which is conducted during an election.

Legislative updates was the next item under old business. Mr. Brant advised he had no new legislation to report since the passing of Act 142 providing for joint election of Governor and Lt. Governor. He further advised no new legislation is expected to pass as the crossover date has already transpired.

The budget was the next item of old business. Mr. Brant stated the budget was passed by the Senate. He explained that in regard to the SEC, the Senate and House versions are the same. Mr. Brant informed the board the budget includes \$250,000 in recurring funds for security, \$650,000 to recoup expenses for the many Special Elections held last year, \$4,000,000 in recurring funds for the voting system replacement and \$4,000,000 for a voting system refresh of the current system. He also informed the board the SEC will receive approximately \$6,000,000 in HAVA funds in a few weeks. This SEC is currently looking at ways funds can be utilized to increase security of election infrastructure.

The next item of old business was the PEW grant. Mr. Brant reminded the board the SEC received a grant in the amount of \$177,000 from the Pew Charitable Trust which would make the SEC a member of the Electronic Registration Information Center (ERIC). He also reminded the commission members that membership in ERIC requires the South Carolina Department of Motor Vehicles (DMV)'s participation, and the SEC will not be able to join without providing the DMV data. Mr. Brant reported the SEC received a one month extension until the end of April to meet the requirements to participate.

The information technology security update was the next item of old business. Mr. Snider advised the SEC continues to participate in the Cyber Hygiene program through DHS. He reported no new system vulnerabilities have been identified. Mr. Snider informed the board county directors were recently briefed on new threat actor tactics to breach various election systems by compromising election officials' social media accounts. He further informed the board the SEC is working with DHS to conduct an onsite security assessment the first week of May 2018. Mr. Snider advised he will be meeting today with the National Guard Cyber Security Team to discuss another initiative.

Legal updates was the last item under old business. Mr. Brant advised a response would be filed by the end of the week in the case of Eugene Baten v Henry McMaster, et al. He also advised that Green v SEC was dismissed by a federal judge last week.

Chairman Way reminded the members the next meeting of the SEC is scheduled for Wednesday, May 16, 2018 at 10:00 a.m. and the next State Board of Canvassers (SBC) meeting is scheduled for Friday, May 4, 2018 at 3:00 p.m.

She stated both versions of the budget include \$250,000 in recurring funds for security, \$650,000 to recoup expenses of the special elections held last year, \$4,000,000 in recurring funds for the voting system replacement and \$4,000,000 for a voting system refresh of the current system. Ms. Andino advised the SEC received \$6,000,000 in federal funds which will be used toward the protection of election infrastructure as well as replacement of the voting system. Ms. Andino explained that all states received funds based on their population.

The next item of old business was the PEW grant. Ms. Andino reminded the board that the SEC had until April 30<sup>th</sup> to work out any issues with the South Carolina Department of Motor Vehicles (DMV) since membership in the Electronic Registration Information Center (ERIC) will require providing the DMV's data. Ms. Andino advised an additional and final three month extension was given to the SEC. Ms. Andino further advised the SEC continues to work with the DMV and the Social Security Administration (SSA) in order to resolve any security issues. She also explained that participating in ERIC will help to keep the voter lists more up to date in regard to voters who are deceased or moved out of state.

The information technology security update was the next item of old business. Ms. Andino advised secure end points are being distributed to the counties to provide a method for a more secure transfer election results. She also reported that the SEC is requiring that all temporary employees at county offices receive security training. Ms. Andino stated the SEC has been working with the U. S. Department of Homeland Security (DHS) on an evaluation of the physical security of the SEC office. She advised that DHS will also be assisting with an Election Security and Technology Workshop for county election officials to be held later this summer.

#### THE MEETING OF THE STATE ELECTION COMMISSION (SEC) WAS HELD PURSUANT TO THE FREEDOM OF INFORMATION ACT AND ALL REQUIRED NOTIFICATIONS WERE MADE.

Chairman Way called the meeting to order and asked if all notices of the meeting had been posted as required by the Freedom of Information Act. Mr. Whitmire advised the notices were posted.

#### **Approval of Minutes**

Chairman Way stated the first item of business was the approval of the minutes for meetings held on July 18, 2018 and July 30, 2018 (SEC). Mr. Benson moved to approve the minutes. The motion was seconded by Ms. Bowers. The minutes were approved unanimously.

#### **New Business**

The first item of new business was the Election Security and Technology Workshop. Mr. Whitmire stated that the two-day event was very successful. He advised that representatives from the Department of Homeland Security (DHS), the Federal Bureau of Investigations (FBI), the Multi-Sate Information Sharing & Analysis Center (MS-ISAC) and the Elections Infrastructure sharing and Analysis Center (EI-ISAC) participated and presented information regarding how to prevent cybersecurity attacks. He also

informed the board that every county had a representative in attendance who was able to take that information back to their respective counties.

The certification of candidate names for the general election was the next item of new business. Mr. Whitmire explained that today by noon is the deadline for certifying names to appear on the general election ballots.

The next item was the certification of Unity 4.0.0.3,v4 with Virtual Box (v.5.2.12). Mr. Snider explained that this request for certification and approval for use comes following ES&S's update to the virtualized software used with Unity 4.0. He further explained the change was submitted to the SEC and has been pilot tested. Following certification and approval for use, all November 2018 General Election databases will be built using this version.

Ms. Bowers was disconnected from the call and attempts to reach her were unsuccessful.

A motion was made by Ms. White to certify and approve for use Unity 4.0.0.3,v4 with Virtual Box seconded by Mr. Benson. The motion was unanimous.

#### **Old Business**

The first item of old business was the certification of Unity 4.0.0.3, Version 4. Mr. Snider explained that field testing of a write in and referendum only ballot has not been field tested. This issue is identifying an election with this type of ballot. Opportunities to conduct a field test will continue to be sought.

The information technology security update was the next item of old business. Mr. Snider informed that a lot of information was received at the Election Security and Technology Workshop regarding phishing email campaigns and malicious telephone call techniques used by threat actors. He also informed the Commissioners that the bi-SANS online security courses have been established for all users of SEC networks and systems. Completion of these courses is mandatory and non-completion will lead to the SEC suspending a user's system user ID and password. The deadline to complete the courses is September 1. Howard also informed everyone that the information technology staff participated in a nationwide tabletop exercise with 20 other states via video conferencing on yesterday, August 14, 2018 from noon to 4pm. In closing, Mr. Snider informed the board that the US Department of Homeland Security (DHS) would begin conducting physical security assessments of each county office and their equipment storage area shortly. The target completion date is October 2018.

Mr. Whitmire advised that the State Law Enforcement Division (SLED) is working on installing sensors on voting equipment. Mr. Snider also stated they are working to have a portion installed before the General Election.

A legal update was the next item under old business. Mr. Brant stated there are no updates in the Eugene Baten v. Henry McMaster, et al. case. He reminded the board this case is a challenge to the winner takes all electoral college system. Regarding the SEC v. James John Todd Kincannon, he further reminded the board a temporary injunction was issued due to unusually burdensome Freedom of Information Act (FOIA) requests. He advised there are not updates at this time. With regards to Bucky Mock v. Clarendon County Board of VR and Elections, et al., Mr. Brant explained this case involves a challenge to the qualifications of a party's nominee for coroner. He also advised that the judge in this case ruled the nominee was disqualified. He explained that filing has reopened for all parties since the nominee was running unchallenged. Mr. Brant informed the board that in the case of Frank Heindel and Phil Leventis v. Marci Andino et al., a summary judgement was filed on July 30th asking the judge to rule based on pleadings.

Chairman Way reminded the members the next State Election Commission meeting will be September 19<sup>th</sup> at 10:00 a.m. and the next State Board of Canvassers meeting will be August 17<sup>th</sup>, 2018 at 10:00 a.m.

With no further business to be discussed, Ms. Benson moved to adjourn the meeting. Ms. White seconded the motion. The motion passed unanimously, and the meeting adjourned.

#### New Business

The first item of new business was the preparations for the General Election. Ms. Andino stated the General Election is 20 days away. She informed the board the SEC held the General Election workshop on September 24, which was rescheduled due to Hurricane Florence. She also informed the commissioners the UOCAVA ballots were mailed in time to meet the state and federal deadlines. Ms. Andino advised that counties have tested their databases, ordered paper ballots and opened their in person absentee precincts. She stated absentee ballots requested have exceeded the requests from previous Gubernatorial election years and the SEC has encouraged the counties to open absentee voting on Saturday, October 27<sup>th</sup> and/or have extended hours. She



further stated the SEC is working with United States Postal Service to get the ballots mailed in the hurricane affected areas by the deadline.

The next item under new business was the certification of ES&S ElectionWare Election Management System V.5.0.1.0, DS200 Precinct Scanner V. 2.17.0.0, DS850 Central Tabulator V. 3.1.0.0, DS450 Central Tabulator V. 3.1.0.0 and ExpressVote V. 2.4.0.0. Elections Systems and Software (ES &S) submitted new software for certification and testing is in process.

The last item of new business was the State of South Carolina Alan Wilson v. Marci Andino. Ms. Andino explained this is a friendly suit to extend the voter registration deadline to today, October 17<sup>th</sup>, 2018 due to Hurricane Florence. The judge granted the request for extension.

Ms. Andino informed the board that as a member of the Electronic Registration Information Center (ERIC) and in order to meet its requirement, the SEC mailed 940,000 postcards to unregistered citizens which also indicated the extended deadline.

#### **Old Business**

The first item of old business was the certification of Unity 4.0.0.3, Version 4. Ms. Andino explained this item is being carried over pending testing of an election with only write-in candidates and an election with only a question on the ballot.

An information technology security update was the next item under old business. Ms. Andino stated the weekly scans performed by the Department of Homeland Security have not discovered any new vulnerabilities. She also stated our private security partner is rescanning our systems for validation of remediation from past scans. Ms. Andino informed the board we are implementing geofencing on the public portion of Voter Registration and Elections Management System (VREMS) and a portion of the SEC's website, SCVotes. She explained this blocks IP addresses from certain countries.

Ms. Andino stated the SEC continues to work to harden the defenses of the county offices. She reported the South Carolina Law Enforcement Division (SLED) currently has installed sensors in 17 counties. Additional counties are being added, with a statewide rollout set for prior to the 2020 PPP.

A legal update was the next item under old business. Mr. Brant reported in the Eugene Baten v. Henry McMaster, et al., a judge will hear the case in November. Mr. Brant also reported there are no updates in the case of the SEC v. James John Todd Kicannon or in the case of Frank Heindel and Phil Leventis v. Marci Andino, SEC. In Bucky Mock v. Clarendon County Board, et al., the Supreme Court affirmed the ruling of the lower court. The second candidate will not be added to the ballot. Chairman Way reminded the members the next State Board of Canvassers meeting will be November 14, 2018 at 10:00 a.m., with the State Election Commission meeting immediately following.

Ms. Bowers inquired as to how the participating counties were selected. Ms. Andino explained a letter was sent encouraging all counties to have the devices installed and she further explained the goal is for all counties to have them installed as it is another level of security.

A legal update was the next item under old business. Ms. Andino reported the Eugene Baten v. Henry McMaster, et al. case was heard and no decision has been rendered. She also reported there are no updates in the case of the SEC v. James John Todd Kicannon or in the case of Frank Heindel and Phil Leventis v. Marci Andino, SEC.

Chairman Way reminded the members the next State Election Commission meeting will be on December 19, 2018. Ms. Andino advised there may be appeals filed, which would have to be heard by the State Board of Canvassers by December 10, 2018.

Ms. Andino welcomed the four new commission members and advised that all notice requirements of the Freedom of Information Act had been complied with.

### **Approval of Minutes**

Ms. Andino explained that the recent replacement of all sitting commission members has created a somewhat novel situation for the agency whereby today's agenda includes the approval of minutes from several meetings conducted prior to any current member's service on the commission. Ms. Andino explained that, consistent with agency standard practices, draft minutes summarizing any actions and discussions from these prior meetings have been prepared by staff and presented to each member for consideration. Counsel suggested that if the new members are not comfortable approving minutes from meetings they were not present or responsible for, the draft minutes could still be published as "unofficial" minutes with a notation explaining the situation to ensure compliance with the Freedom of Information Act. The commission members agreed to have the minutes published as unofficial.

#### New Business

The first item of new business was the introduction of the new commission members. Ms. Andino explained there is still one vacancy and no decision has been communicated regarding who will be the chairman. The members introduced themselves.

The next item of new business was the agency's 50<sup>th</sup> anniversary. Ms. Andino explained that January 1 marks the 50<sup>th</sup> anniversary of the agency's creation and establishment

as an independent agency. Prior to January 1, 1969, election administration was conducted under the authority of the Secretary of State's Office. This separation of election administration from the authority and management of partisan, elected officials protects the integrity of the state's elections and is now seen as a model for the legal structure of election agencies throughout the country. She stated she is only the fourth executive director of the agency since its establishment. As part of the celebration, the Governor has drafted a proclamation declaring 2019 as S. C. State Election Commission 50<sup>th</sup> Anniversary Year throughout the state. She further stated there will be events throughout the year celebrating the anniversary.

The next item under new business was the special election for State House District 14. Ms. Andino advised it was triggered by the resignation of Representative Mike Pitts and will be held in Greenwood and Laurens Counties. The primary will be held on February 19, the runoff on March 5, and the special election on April 23.

The request for proposals for a statewide voting system solution was the next item of new business. Ms. Andino informed the board that a vendor neutral solicitation was released on December 7 and that all vendors are encouraged to bid. She advised a new system must be federally certified and have a paper record of each voter's voted ballot due to security concerns. System selection will be made by an evaluation panel of subject matter experts which will consist of state and county election officials. Proposals are due by March 4. She stated the intent to award should be issued in May or June of 2019 with implementation beginning around July 1 of 2019.

County compliance was the next item of new business. Ms. Andino informed the commissioners that in 2014, the State Election Commission was given supervisory authority over the counties to ensure compliance with federal and state laws as well as policies and procedures of the State Election Commission. She advised that noncompliance letters are being sent to Charleston, Berkeley and Dorchester Counties for failure to open for absentee voting the Saturday prior to the general election as directed by the State Election Commission.

The next item of new business was the certification of Hart Intercivic Verity Voting 2.3. Ms. Andino explained that this voting system is in testing and will be used in an election in February. She advised a report will be presented to the commission for approval once testing is completed.

#### **Old Business**

The first item of old business was the certification of Unity 4.0.0.3, Version 4. Ms. Andino explained this item has been tested and used in an all write-in election. She recommended the board certify and approve it for use. Ms. Loveday made a motion to certify and approve for use. It was seconded by Mr. Edler. The vote in favor of the motion was unanimous.

An information technology security update was the next item under old business. Ms. Andino reported the SEC continues to take all reasonable measures to secure the state's election infrastructure. She also reported we continue to participate in weekly scans performed by the Department of Homeland Security and that no new vulnerabilities have been discovered.

A legal update was the next item under old business. Mr. Brant reported that in the case of <u>Eugene Baten v. Henry McMaster, et al.</u>, a hearing was held on a co-defendant's motion to dismiss the suit and the parties are waiting for the judge's ruling. He also reported there are no updates in the case of the <u>SEC v. James John Todd Kincannon</u> or in the case of <u>Frank Heindel and Phil Leventis v. Marci Andino, SEC</u>.

Ms. Andino reminded the members the next State Election Commission meeting will be January 16, 2018 at 10:00 a.m.

With no further business to be discussed, Mr. Wells moved to adjourn the meeting. Ms. Loveday seconded the motion. The motion passed unanimously, and the meeting adjourned.

## Summary

Election Systems & Software (ES&S) applied for South Carolina certification of the following software on March 9, 2018.

Unity 4.0.0.3v4 rev 1

The ES&S Unity 4.0.0.3v4 voting system (Unity 4) uses IVIM Image Manager 3.1.1.0 which did not support elections in which the first office on the ballot contained only write in candidates.

ES&S submitted Unity 4.0.0.3v4 rev 1 that replaced IVIM 3.1.1.0 with IVIM 3.1.2.0. In order to certify this, two rounds of tests were run. The first round of tests run was in house. After that round of testing was successfully completed, a parallel test was run in Clarendon County. The tests were performed to validate that elections in which the first contest is a write in only contest or any contest is a write in only contest can be accurately built and tabulated.

The first round of testing (four tests) occurred between March 22 and March 27 During those tests, databases in which the first office on the ballot contained only write in candidates was successfully built and test ballots entered. The results were successfully tabulated.

The parallel test was performed December 4, 2018 in the Paxville Precinct in Clarendon County

These tests were successful as to functionality of voting systems as required by the South Carolina Code of Laws Sections 7-13-1620 and 7-13-1640. Therefore, the SEC testing team recommends certification of Unity 3.4.0.1 and the DS200 and DS850 optical scanners.

Approval and adoption of this voting system for use under Section 7-13-1655 is not a part of this report.

## Independent Testing Authority (ITA) Report

Specifically, the certified software component, iVIM v. 3.1.1.0, was updated to iVIM v. 3.1.2.0 to correct the generation of iVotronic files for an election that contains only a single contest, a 'No Candidate Filed' text box,1 and a write-in area on the ballot. No other components were modified from the U4003v4 release certified by the South Carolina SEC on June 21, 2017.

Pro V&V, an Election Assistance Commission (EAC) accredited Voting System Test Laboratory (VSTL), performed a source code review, trusted build, functional review, and issued their final test report addendum on March 9th. Included with this cover letter is a CD-ROM containing this cover letter, Pro V&V's addendum to the test report, and ES&S' revised Technical Data Package (TDP) for Unity 4.0.0.3 version 4 (Revision 1).

ES&S stipulates that the only difference between Unity 4.0.0.3v4 and Unity 4.0.0.3v4 rev 1 the latter was modified to support the conditions in the paragraphs above.

On January 1, 2007, the United States Election Assistance Commission (EAC) began the HAVA requirement of accreditation of Independent Testing Authorities and has since accredited Wyle Laboratories and SLI Global Solutions (formerly SysTest Labs) to test voting systems against the 2002 Voting System Standards and the 2005 Voluntary Voting System Guidelines.

# Referenced Sections of the South Carolina Code of Laws

SECTION 7-13-1620:

(A) Before any kind of voting system, including an electronic voting system, is used at an election, it must be approved by the State Election Commission, which shall examine the voting system and make and file in the commission's office a report, attested to by the signature of the commission's executive director, stating whether, in the commission's opinion, the kind of voting system examined may be accurately and efficiently used by electors at elections, as provided by law. A voting system may not be approved for use in the State unless certified by a testing laboratory accredited by the Federal Election Assistance Commission as meeting or exceeding the minimum requirements of federal voting system standards.

(B) A person or company who requests an examination of any type of voting system shall pay a nonrefundable examination fee of one thousand dollars for a new voting system. A nonrefundable examination fee of five hundred dollars must be paid for an upgrade to any existing system. The State Election Commission may reexamine any voting system when evidence is presented to the commission that the accuracy or the ability of the system to be used satisfactorily in the conduct of elections is in question.

#### SECTION 7-13-1640:

(A) Any kind or type of voting machine may be approved by the State Board of Voting Machine Commissioners which is so constructed as to fulfill the following requirements. It shall:

(1) provide facilities for voting for all candidates of as many political parties or organizations as may make nominations of candidates at any election, for or against as many questions as may be submitted at any election, and at all general or special elections, permit the voter to vote for all of the candidates of one party or in part for the candidates of one or more parties;

(2) permit the voter to vote for as many persons for any office as he is lawfully entitled to vote for, but no more;

(3) prevent the voter from voting for the same person more than once for the same office;

(4) permit the voter to vote for or against any question he may have the right to vote on, but no other;

(5) if used at a primary election, be so equipped that all rows except those of the voter's party can be locked out by the managers of election by means of an adjustment on the outside of the machine;

(6) correctly register or record and accurately count all votes cast for any and all candidates and for or against all questions;

(7) be provided with a "protective counter" or "protective device" whereby any operation of the machine before or after the election will be detected;

(8) be provided with a counter which shows at all times during an election how many persons have voted;

(9) be provided with either an illustration or a mechanical model, illustrating the manner of voting on the machine, suitable for the instruction of voters; and

(10) ensure voting in absolute secrecy.

(B) A machine must be provided with a device for each party and for each nomination by petition for voting for presidential and vice-presidential candidates in one operation and listing the candidates by name and by party or indicating the candidate is nominated by petition.

(C) If approved after July 1, 1999, or if an upgrade in software, hardware, or firmware is submitted for approval as required by Section 7-13-1620(B), the voting system must be able to electronically transmit vote totals for all elections to the State Election Commission in a format and time frame specified by the commission.

#### SECTION 7-13-1655:

(A) As used in this section, "voting system" means:

(1) the total combination of mechanical, electromechanical, or electronic equipment, including the software, firmware, and documentation required to program, control, and support the equipment that is used to:

(a) define ballots;

(b) cast and count votes;

(c) report or display election results; and

(d) maintain and produce audit trail information;

(2) the practices and associated documentation used to:

(a) identify system components and versions of these components;

(b) test the system during its development and maintenance;

(c) maintain records of system errors and defects;

(d) determine specific system changes to be made to a system after the initial qualification of the system; and

(e) make available materials to the voter, such as notices, instructions, forms, or paper ballots.

(B) The State Election Commission shall:

(1) either approve and adopt one voting system to be used by authorities charged by law with conducting elections, or approve and adopt multiple voting systems if the commission, in its discretion, determines not to adopt one voting system;

(2) support the authorities charged by law with conducting elections by providing basic level training for personnel in the operation of the voting system approved and adopted by the commission;

(3) support all aspects of creating the ballots and the database of the voting system that is approved and adopted; and

(4) comply with the provisions of Chapter 35 of Title 11 in procuring a voting system or systems, as defined in subsection (A).

The above modules/components were fully tested by State Election Commission, Voter Services Division staff. Tabulated results matched the expected results in the tests. .
